

## How do I register for Staff NYLT?

Any scout that wants to be on Staff for NYLT 2019 course and meets the eligibility requirements should complete this registration before October 26, 2018. Applications will be reviewed and a complete information package will be called if you are selected for staff. Please make sure the e-mail and phone number provided are working and checked.

## Age and Rank Requirements

The following are the minimum requirements to attend NYLT:

- ⇒ 14 or Older
- ⇒ First Class or Higher
- ⇒ Previously Attended NYLT
- ⇒ Recommendation by Scoutmaster/Crew Advisor

## Staff Selection Criteria

All scouts that meet age and rank requirement, and have previously attended NYLT can request to be on staff for this course. We are seeking enthusiastic, dedicated, and hard working individual that would like to run the NYLT 2019 training course. The staff is responsible for the presentation of the course including the presentations of all course material. Staff will be assigned staff positions and presentation at the first staff training course. There are only 14 staff positions available, selection will be based on previous experience and interview with course advisors. Staff is expected to attend mandatory training sessions.

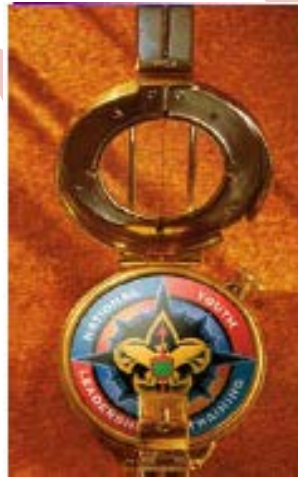

The course is designed to provide activities and skills that you will need to be an effective leader in your troop. You will meet other scouts in the council and share ideas and knowledge.

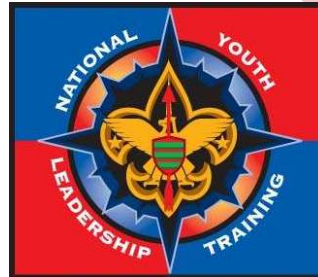
You will be assigned to a patrol as part of a troop. You will camp with your patrol and participate in activities with your patrol. You will learn effective teaching, communications, and leadership.
